3. How We Use Your Information

We use the information we collect in the following ways:

- To provide, operate, and maintain our Website.
- To improve, personalise, and expand our Website.
- To understand and analyse how you use our Website.
- To develop new products, services, features, and functionality.
- To communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the Website, and for marketing and promotional purposes.
- To process your transactions and manage your orders.
- To send you emails.
- To find and prevent fraud.

4. Cookies

Our Website uses cookies to distinguish you from other users of our Website. This helps us to provide you with a good experience when you browse our Website and also allows us to improve our site.

Types of Cookies We Use:

- **Essential Cookies**: These are necessary for the Website to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in, or filling in forms.
- Analytical/Performance Cookies: These allow us to recognize and count the number
 of visitors and to see how visitors move around our Website when they are using it. This
 helps us to improve the way our Website works, for example, by ensuring that users are
 finding what they are looking for easily.
- **Functionality Cookies**: These are used to recognize you when you return to our Website. This enables us to personalize our content for you, greet you by name, and remember your preferences (for example, your choice of language or region).
- Targeting Cookies: These cookies record your visit to our Website, the pages you have visited, and the links you have followed. We will use this information to make our Website and the advertising displayed on it more relevant to your interests. We may also share this information with third parties for this purpose.

5. Managing Cookies

You can set your browser to refuse all or some browser cookies, or to alert you when websites set or access cookies. If you disable or refuse cookies, please note that some parts of this Website may become inaccessible or not function properly.

6. Data Retention

Your data will be stored only until the purpose for which it was collected has been achieved. Once this purpose is fulfilled, your data will be securely deleted or anonymised in accordance with our data retention policies and applicable laws.

7. Data Security

We have implemented appropriate security measures to prevent your personal data from being accidentally lost, used, or accessed in an unauthorized way, altered, or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors, and other third parties who have a business need to know.

8. Your Data Protection Rights
